- 1. These rules may be called the Constable, Class III, in the Gujarat State Reserve Police Force Recruitment Rules, 2016.
- 2. Appointment to the post of Constable, Class III in the subordinate service in the Gujarat State Reserve Police Force shall be made by direct selection.
- 3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-
 - (a) not be less than 18 years of age and not be more than 33 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided further that the upper age limit may be relaxed in favour of a candidate belonging to the Scheduled Castes, Scheduled Tribes and Socially and Educationally Backward Classes or women in accordance with the provisions of the Gujarat Civil Services Clasification and Recruitment (General) Rules, 1967;

- (b) have passed the Higher Secondary School Certificate Examination from the Secondary and/or Higher Education Board or possess an equivalent qualification recognised as such by the Government;
 - (c) possess the minimum requisite standrds of physique as specified in Appendix 'A' appended to these rules;
- (d) possess the basic knowlede of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (e) possess adequate knowledge of Gujarati or Hindi or both.
- 4. Notwithstanding anything contained in any rules, a candidate selected by direct recruitment shall be appointed on contractual basis in accordance with and during recruit's training on such terms and conditions as prescribed in Government Resolution Home Department No.MHK/1011/2223/C dated 1st June 2016
- 5. The candidate appointed in accordance with rule 4 shall during the stipulated period of service on contractual basis require to undergo such training and pass the post-training examination in accordance with the rules prescribed by the Government.
- 6. The candidate appointed in accordanace with rule 4 shall, during the stipulated period of service on contractual basis, require to pass the ccc examination in accordance with the Gujarat Civil Services Compyuter Compentancy training and Examination rules, 2006.
- 7. The candidate appointed by direct selection shall have to possess valid light/heavy motor vehicle driving license within a period of two years after his appoinment.
- 8. The candidate appointed by direct selection shall require to undergo such training and to pass such examination as may be prescribed by the Government.

The candidate appointed by direct selection shall require to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by the Government from time to time.


